## What can the EU Talent Pool Pilot do for you?

Through the EU Talent Pool Pilot, you can create your CV and show your skills to more than 4 000 carefully validated and registered employers and EURES Members and Partners.

There are over 3 million job vacancies on the EURES portal that you can browse. Employers can search for candidates through a CV database.

## Who can apply?

If you are a jobseeker enjoying temporary protection under the EU Temporary Protection Directive, or adequate protection under national law, you have the right to work in the Member State in which you are registered.



## Can I find work in any EU country?

You can search and find jobs in EU countries and publish your CV. However, you must consult further information regarding your mobility and registration rights and obligations.

In addition, the initiative service is not available in all EU countries. Consult the map on the landing page to know which ones provide support under the EU Talent Pool Pilot.

## Will my personal data be protected?

To protect personal data from potential abuse, access to the portal will be secured: you will create an EU Login with a two-step authentication process. Once created, the CV will only be accessible by advisers, as well as employers and intermediaries registered and validated in EURES. You can also choose to publish an anonymised CV.
